### **From the School Council By-Laws, Article VII: Elections**

Elections shall take place each year in the month of May.

The **electing body for the parent members shall consist of all parents** eligible to serve as a parent member of the School Council. **(Specify Nomination and Election Process)**

The **electing body for the teacher members shall consist of all certified personnel** eligible to serve as a teacher member of the School Council. **(Specify Nomination and Election Process)**

The council may select community business persons and other members providing that parents hold a majority on the council.
